OFFICE ORDER

It has been observed that, HMV Driving Licenses are being issued from different RTO offices on the basis of certificates issued by different private Driving Training Institutes, which do not have sufficient Infrastructures for imparting driving training in HMV. One Inspection Audit of such Institutes was conducted by Addl. Commissioner, Transport(Admn.) and Addl. Commissioner, Transport(Technical) along with concerned Deputy commissioners and RTO/MVI. It has been found that most of the Institutes do not have sufficient Infrastructure for imparting driving training in HMV. Where ever infrastructure is available premises and vehicles status are not complying the requirement of CMVR,1989. As per requirement Premises and vehicle should be owned by the Institute or Owner of the Institute and if under lease agreement it should have been duly registered. Out of the 28 Institutes Inspected 13 Institutes have been identified as complying the minimum infrastructure requirements along with required premises and vehicle status. It is hereby ordered that hence forth **Driving training Certificate in Form-5** required for issue of HMV Driving License should not be accepted from any other Institute except these 14 nos. of Institutes mentioned below including **GoO – AL HMV Driver Training Institute, Chatia**. Untill further order in Odisha the following 14 Institutes are authorised to impart Driving Training in HMV and issue Form-5. Authorisation to impart Driving Training in HMV of all other left out Institutes shall be suspended till they possess minimum infrastructure and comply the requirements of CMVR,1989 .

It is hereby further ordered that, while accepting Form-5 the following aspects are meticulously followed.

1. Sl. Nos.02 to 14 are authorised to impart HMV driving training to 30 trainees per month only as they have one truck only. But GoO –AL HMV Driver Training Institute, Chatia is authorised to impart training to 150 trainees per month as they have engaged 05 vehicles.
2. RTO/MVI should monitor every month the training imparted by the concerned DTI and after cross checking the related registers the RTO should put signature in each & every Form-5 issued by DTI and as it should tally with the admission and attendance register being limited to 30 per month.
3. If Form-5 is not countersigned by concerned RTO it should not be accepted.
4. Data of all the trainees passed out of concerned DTI should be uploaded in the web site by the concerned RTO.
5. Form-5 of any other unauthorised Institutes should not be accepted and license of these unauthorised Institutes should be suspended until further orders.
6. RTO/MVI should visit these institutes intermittently to assess the training imparted by the training schools.
