ITEM NO – 1:

**BHUBANESWAR TO PURI (four trips) & BHUBANESWAR TO
CUTTACK (two trips)**

Pursuant to the advertisement published in Daily Odia News Paper "Daritri" and English News Paper "The New Indian Express" dated 22.03.2016, the following (**FIVE**) Stage Carriage Operators have applied for grant of Permanent Permit on the above mentioned notified route. The vacancy arose due to surrender of permanent permit by Smt. Jyotsnamayee Singh in respect of vehicle No.OR-05V-4524.

- i) Sri Upendra Pradhan, owner of vehicle No.OD-02Z-6799 (Model-2015).
- ii) Sri Rajkishore Mohanty, owner of vehicle No.OD-02AB-4575 (Model-2015).

Based on the marks secured as per evaluation criteria, in terms of model of vehicle and facility provided, Sri Upendra Pradhan, owner of vehicle No.OD-02Z-6799, ranked-3rd (40 marks) as per statement under **Annexure-1** annexed to this proceeding.

Sri Raj Kishore Mohanty, owner of vehicle No.OD-02AB-4575 appeared in person. He has not submitted Bank Guarantee in as required under Section 71(3)(d)(i) of M.V Act, 1988 to adjudge his merit.

Based on the marks secured as per evaluation criteria, in terms of model of vehicle and facility provided Sri Rajkishore Mohanty, owner of vehicle No.OD-02AB-4575, ranked 2nd (45 marks) as per statement under **Annexure-1** annexed to this proceeding.

Sri Ashok Kumar Jena, Advocate appeared on behalf of Sri Kalandi Charan Mansingh, owner of vehicle No.OD-02X-5266. He has submitted Solvency Certificate as required under Section 71(3)(d)(i) of M.V Act, 1988 to adjudge his merit.

Based on the marks secured as per evaluation criteria, in terms of model of vehicle and facility provided Sri Kalandi Charan Mansingh owner of vehicle No.OD-02X-5266, ranked-3rd (40 marks) as per statement under **Annexure-1** annexed to this proceeding.



Sri Bikramaditya Kar, owner of vehicle No.OD-05S-4298 appeared in person. He has submitted Bank Guarantee as required under Section 71(3)(d)(i) of M.V Act, 1988 to adjudge his merit.

Based on the marks secured as per evaluation criteria, in terms of model of vehicle and facility provided Sri Bikramaditya Kar, owner of vehicle No.OD-05S-4298, ranked-1ST (50 marks) as per statement under **Annexure-1** annexed to this proceeding.

Smt. Sujata Pattanaik, owner of vehicle No.OD-02N-7777 is absent on call.

Based on the marks secured as per evaluation criteria, in terms of model of vehicle and facility provided Smt. Sujata Pattanaik, owner of vehicle No.OD-02N-7777, ranked-4th (20 marks) as per statement under **Annexure-1** annexed to this proceeding.

She has not submitted Solvency Certificate as required under Section 71(3)(d)(i) of M.V Act, 1988 to adjudge her merit. Hence she did not qualify to get the permit.

Taking all the factors in to account and upon perusal of marks obtained by applicant Sri Bikramaditya Kar, details of which is annexed as **Annexure-1**, after deliberations, it was decided to grant permanent stage carriage permit in favour of Sri Bikramaditya Kar owner of vehicle No. OD05S-4298 in the route BHUBANESWAR TO PURI (four trips) & BHUBANESWAR TO CUTTACK (two trips) for a period of five years as Ordinary Service subject to verification of original documents submitted by him. No change of vehicle and timing shall be allowed. The grantee shall not leave the route and shall not surrender the permanent permit so granted at least within one year. The grantee shall lift the permit within a period of ten days from the date of communication of grant order failing which such grant of permit is liable to be cancelled. The grantee shall not withdraw the vehicle or replace by any other vehicle till the validity of the



permanent permit on this given route. The grantee can however replace the present vehicle by another vehicle which is either equal to or higher in terms of model and facilities provided in the present vehicle. Such replacement shall not be done before completing one year of service except in case of accident or any exigent reasons with the prior concurrence of competent authority. These conditions shall form a part of the Permit conditions. Before issue of permit Tax payment position, Audit and VCR clearance should be obtained and it should be ensured that the vehicle was not off road on the date of application and on the date of consideration.
