3) POLICY DECISION:

Transfer of stage carriage permit.

After due deliberation and supersession of decision taken in 279th meeting, it was resolved to consider transfer of stage carriage permit on case to case basis between family members only i.e. father and mother, uterine brothers and their wives, sons, unmarried daughters and sisters.

ITEM NO. 4.1. VALIADIHI TO BHUBANESWAR AND BHUBANESWAR TO NAYAGARH AND BACK :-

Pursuant to the advertisement published in Daily Odia News Paper "Dharitri" and English News Paper "The New Indian Express" dated 11.09.2016, the following (**TWO**) Stage Carriage Operators have applied for grant of Permanent Permit on the above mentioned notified route. The vacancy arose due to non-renewal of Permanent permit in respect of hired vehicle. OR25-7266 on the aforementioned route.

- i) Sri Pradeep Kumar Mohanty, owner of vehicle No. OD25D-3666 (Model-2016)
- ii) Sri Sudhir Kumar Nayak, owner of vehicle No. OD02V-5229 (Model-2015).

Sri M.B.K. Rao, Advocate appeared on behalf of Sri Pradeep Kumar Mohanty, owner of vehicle No. OD25D-3666. He has submitted Bank Guarantee of Rs.99,000/- as required under Section 71 (3) (d) (i) of M.V Act to adjudge his merit.



Based on the evaluation criteria, in terms of model of vehicle, type of facilities in bus, Sri Pradeep Kumar Mohanty owner of vehicle No.OD25D-3666 secured 65 marks and ranked-1st. The detail marks statement is in **Annexure-1**.

Sri Sudhir Kumar Nayak, owner of vehicle No.OD02V-5229 appeared in person. He has submitted Solvency Certificate of Rs.99,000/- as required under Section 71 (3) (d) (i) of M.V Act to adjudge his merit.

Based on the marks secured as per evaluation criteria, in terms of model of vehicle, type of facilities in bus, Sri Sudhir Kumar Nayak, owner of vehicle no OD02V-5229 ranked-2nd (45 marks) as per statement under **Annexure-1** annexed to this proceeding.

Taking all the factors in to account and upon perusal of marks obtained by applicant namely Sri Pradeep Kumar Mohanty, owner of vehicle No.OD25D-3666 of aforesaid vehicles details of which is as **Annexure-1**, and after deliberations, it was decided to grant permanent stage carriage permit in favour of Sri Pradeep Kumar Mohanty, owner of vehicle No.OD25D-3666 in the route **VALIADIHI TO BHUBANESWAR AND BHUBANESWAR TO NAYAGARH AND BACK** for a period of five years as **Ordinary Service subject to verification of original documents submitted by him**. No change of vehicle and timing shall be allowed. The grantee shall not leave the route and shall not surrender the permanent permit so granted at least within one year. The grantee shall lift the permit within a period of ten days from the date of communication of grant order failing which such grant of permit is liable to be cancelled. The grantee shall not withdraw the vehicle or replace by any other vehicle till the validity of the permanent permit on this given route. The grantee can however replace the present vehicle by another vehicle which is either equal to or higher in terms of model and facilities provided in the present vehicle. Such replacement shall not be done before completing one year of service except in case of accident or any exigency with the prior concurrence of competent authority. These conditions shall form a part of the Permit conditions. Before issue of permit Tax payment position, Audit and VCR clearance should be obtained and it should be



ensured that the vehicle was not off road on the date of application and on the date of consideration.
